

PRIVACY POLICY

(GDPR/RODO INFORMATION CLAUSE)

This PRIVACY POLICY (GDPR/RODO INFORMATION CLAUSE) sets out the rules for the use of cookies by the website www.zubrowa10.pl (hereinafter referred to as the "Website") and the rules regarding the processing of personal data by the Administrator in the HOME tab [contact panel], including the grounds, purposes and scope of personal data processing and the rights of persons whose data relate to.

I. GENERAL INFORMATION

1. The owner of the Website www.zubrowa10.pl is ŻUBROWA 10 JAN WALENCIK.
2. A User of the Website is an entity for whom the owner of the Website provides services electronically.
3. In order to handle correspondence between the User and the owner of the Website, The User fills in the contact form and sends it (in the HOME tab [contact panel]).

II. INFORMATION CONTAINED IN THE SERVICES

1. The Website obtains information about Users by:
 - a) voluntary entering of data by the User in the contact form (in the HOME tab [contact panel]);
 - b) collection of web server logs by the hosting provider.
2. The Website can also store information about the connection parameters (time stamp, IP address).
3. The data used in the contact form (in the HOME tab [contact panel]) can be made available to third parties only with the User's consent.
4. The data provided in the contact form (in the HOME tab [contact panel]) may constitute a set of potential customers of the Website owner.
5. Data provided in the contact form (in the HOME tab [contact panel]) is processed in order to handle correspondence.

III. INFORMATION ABOUT COOKIES

1. The Website uses cookies.
2. Cookie files (cookies) are IT data, in particular text files, which are stored on the Website User's end device and are intended for using the Website pages.
3. The entity placing cookies on the Website User's end device and accessing them is the owner of the Website.
4. Cookies are used to identify the software used by the Website User and to optimize the functioning and security of the Website. Cookie files contain data of

the domain they come from, determine the time of their storage on the User's computer as well as have an assigned number.

5. There are two main types of cookie files used within the Website:
 - a) session files, which are temporary files stored on the User's end device until logging out, leaving the website or turning off the software (web browser),
 - b) permanent files, which are stored on the User's end device for the time specified in the cookie file parameters or until they are deleted by the User.
6. The User has the option of limiting the use of cookies, however, this limitation may affect the functionality and availability of some of the functions contained on the Website pages.
7. In terms of information about the User's preferences collected by the Google advertising network, the User may view and edit information resulting from cookies using the tool: <https://www.google.com/ads/preferences/>.

IV. DATA SHARING

1. Submitting the application by the User is tantamount to consenting to the storage and processing of personal data by the Website in order to provide services, based on Article 6(1)(a) of the Regulation of the European Parliament and of the Council of the European Union 2016/679 of April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation).
2. The Administrator of personal data processed for the purpose of providing services is the owner of the Website.
3. The User has the right to access its data for inspection and verification purposes and has the right to request the Administrator to delete its personal data.
4. The data made available on the Website is made available to third parties only within the limits permitted by law.
5. Data enabling the identification of a natural person are made available only with the consent of that person.
6. The Website owner has the right to provide information collected by the Website to authorized bodies on the basis of lawful requests to the extent resulting from the request.

V. INFORMATION ON DATA COLLECTION – CONTACT FORM

1. When using our online form (contact form in the HOME tab [contact panel]), the data collected is used solely to enable contact with the Users using the contact data entered into the form.
2. Electronic registration of this data is necessary if the User wants to use this service. These data, provided voluntarily by the User of our Website, may enable / facilitate the identification of the User.

VI. INFORMATION CLAUSE FOR VISITORS TO THE WEBSITE

In accordance with Article 13 of the Regulation of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, GDPR/RODO), we inform you that:

- 1. The Administrator of your personal data is Jan Walencik.**
- 2. Your personal data is processed for the purpose of registration in the Website modules that require it, on the basis of Article 6(1)(a) of the General Data Protection Regulation of April 27, 2016.**
- 3. The recipients of your personal data will be entities authorized to receive them on the basis of legal provisions or authorized based on your consent.**
- 4. Your personal data will be stored until the end of the Website's activity.**
- 5. You have the right to request the Administrator to access personal data, the right to rectify it, delete or limit processing, and the right to transfer data.**
- 6. You have the right to lodge a complaint with the supervisory authority competent in matters relating to the protection of personal data.**
- 7. Providing personal data is voluntary, however, it may be necessary to use some of the Website's resources.**

VII. SAFETY RULES

- 1. The Website Administrator ensures the security of personal data through appropriate technical and organizational measures aimed at preventing unlawful data processing as well as their accidental loss, destruction or damage. In addition, we take special care to ensure that personal information is:**
 - a) correct and processed lawfully,**
 - b) obtained only for specific purposes and not further processed in a manner inconsistent with these purposes,**
 - c) adequate, appropriate and not redundant,**
 - d) accurate and up to date,**
 - e) not stored longer than necessary,**
 - f) processed in accordance with the rights of persons (they relate to), including the right to reserve sharing,**
 - g) safely stored,**
 - h) non-transferable without adequate protection.**

VIII. SHARING OF USER INFORMATION

- 1. The Website Administrator does not pass on, sell or lend Users' data to third parties or institutions.**

2. **The Administrator of the Website may present to the cooperating institutions statistical summaries of usage of the Website, which, however, do not allow to identify individual Users. In the event of control by the President of the Personal Data Protection Office, your data may be made available to the employees of the Inspectorate in accordance with the GDPR/RODO regulation. In the event of a violation of the law, or when it will be required by law, we may disclose your data to judicial authorities on the basis of relevant provisions of law/court order/other documents.**

IX. FINAL PROVISIONS

The Website Administrator reserves the right to make changes to the PRIVACY POLICY (GDPR/RODO INFORMATION CLAUSE) in the future. By using the Website, the User accepts the changes in the new version of the PRIVACY POLICY.
